The federal Department of Education's Office of Civil Rights (OCR) enforces five federal statutes that prohibit discrimination against students with disabilities in education programs and activities that receive federal financial assistance.

These laws prohibit discrimination on the basis of race, color, national origin, gender, age or disability.

OCR is also responsible for enforcing Title II of the Americans with Disabilities Act of 1990. These civil rights laws apply to all state and municipal education programs, including elementary and secondary school systems, colleges and universities, vocational schools, proprietary schools, state vocational rehabilitation agencies, libraries and museums that receive funding from the U.S. Department of Education.
